NOTICE IS HEREBY GIVEN that a Special Election will be held for San Francisco Bay Restoration Authority, on June 7, 2016, and that the following measure will be submitted to the voters:

Measure AA

San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Program. To protect San Francisco Bay for future generations by reducing trash, pollution and harmful toxins, improving water quality, restoring habitat for fish, birds, and wildlife, protecting communities from floods, and increasing shoreline public access, shall the San Francisco Bay Restoration Authority authorize a parcel tax of \$12 per year, raising approximately \$25 million annually for twenty years with independent citizen oversight, audit, and all funds staying local?

NOTICE IS ALSO HEREBY GIVEN that any written arguments for or against the measure(s) to be submitted to the voters must be filed with the office of the Registrar of Voters, 435 Fiscal Drive, Santa Rosa, CA 95403, no later than 5 p.m. on March 15, 2016. Arguments must be accompanied by a Statement of Accuracy, available from the Registrar of Voters, signed and dated by the author(s). Arguments shall not exceed 300 words.

NOTICE IS ALSO HEREBY GIVEN that if an argument in favor of and an argument against the measure(s) are submitted, copies will be mailed to the respective authors in order that they may submit a rebuttal argument. Rebuttal arguments must also be accompanied by a Statement of Accuracy, signed and dated by the author(s). The deadline for filing a rebuttal argument will be 5 p.m. on March 22, 2016. Rebuttal arguments shall not exceed 250 words.

The polls will be open on June 7, 2016, Election Day, between the hours of 7 a.m. and 8 p.m.
