**Resolution No. 60**

**Adopting Amendments to the San Francisco Bay Restoration Authority  
Grant Program Guidelines**

**Whereas**, the San Francisco Bay Restoration Authority (“Authority”) was established by the San Francisco Bay Restoration Authority Act, California Government Code Section 66700 et seq. (“Act”) as a regional entity to generate and allocate resources for the protection and enhancement of tidal wetlands and wildlife habitat in San Francisco Bay and along its shoreline; and

**Whereas**, in June of 2016, The San Francisco Bay Clean Water, Pollution Prevention and Habitat Restoration Measure (“Measure AA”) passed with over a two-thirds majority in the nine-county San Francisco Bay Area; and

**Whereas**, Measure AA is expected to raise approximately \$25 million annually for twenty years; and

**Whereas**, all projects funded by the Authority with funds generated from Measure AA must be consistent with the Act and Measure AA; and

**Whereas**, at its April 27, 2016, June 9, 2017, and September 21, 2018 Governing Board meetings, the Authority adopted and amended the *San Francisco Bay Restoration Authority Grant Program Guidelines*, which describe the Act and Measure AA funding criteria and the Authority’s process for soliciting and evaluating grant applications; and

**Whereas**, Authority staff recommend that the Authority adopt amendments to the *San Francisco Bay Restoration Authority Grant Program Guidelines* to clarify eligibility of projects that involve bringing dredged material to subsidized restoration sites and to make other clarifications. In preparing the amendments, Authority staff considered comments of the Advisory Committee; and

**Whereas**, the attached amendments to the *San Francisco Bay Restoration Authority Grant Program Guidelines* are consistent with the Act and Measure AA.

**Now Therefore Be It Resolved**, that the Governing Board of the San Francisco Bay Restoration Authority hereby adopts amendments to the *San Francisco Bay Restoration Authority Grant Program Guidelines* as shown in Exhibit A to this Resolution 60.


