LEJ planted 6,500 native plants at Sunrise Point, cleaned up trash throughout the project area, provided paid job training to 12 transitional-aged youth (18-25 years old) through their Eco-Apprentice program, and engaged ~ 300 community members in the stewardship of the project area.	\$100,000	\$100,000	Implementation	Application received in FY 2020-21.
