**5. Chair's Report from February 28, 2025 Governing Board Meeting
(INFORMATION)**

Jessica Martini-Lamb, Chair, shared updates from the February Governing Board Meeting. Four new members were welcomed to the Board: Councilmember Brent Blackaby, Councilmember Danielle Cwirko-Godycki, Supervisor Amber Manfree, and Councilmember Princess Washington. Supervisor Lisa Gauthier was reappointed to the Board. Supervisor John Gioia is now serving as Chair, and the Board voted to appoint

Director Karen Holman as Vice Chair. David Lewis provided a presentation on the history of the Restoration Authority. Twenty-two new and returning members to the AC were appointed, and the terms of the current Chair and Vice Chair of the AC were extended to cover the May AC meeting. The Board received staff's preliminary recommendations for 2024-2025 grant round. The Board approved grant of up to 4 million dollars to the California Invasive Plant Council for the Invasive Spartina Project Phase II. They also received the 2024-2025 annual Levee Report for Measure AA. One item was postponed due to time constraints.

David Lewis, Executive Director of Save the Bay, provided background information about the origins of the Measure AA ballot measure. He provided polling data about voter interest and willingness to pay an extra tax for bay restoration through polls dating back to 2006. The two sets of polling provided direction and confidence that Measure AA could pass as a parcel tax in all nine-counties in the 2016 election, and similar polling will be helpful to assess when to place the next version of Measure AA on the ballot.

Sara Haugen provided a summary of the Request for Proposals and grant program evolution since the Authority's inception.

The Grant Round 9 Request for Proposals, which are substantively similar to Round 8 Materials, will be presented to the Board at the June 6, 2025 meeting. The grant round will be open from early July to early October 2025.

AC members will be invited in September to serve as reviewers in the fall for the competitive grant round. Staff are also seeking additional volunteers to serve as Community Grant reviewers as applications come in on a rolling basis.

David Lewis shared that Save the Bay has a fellowship program for policy, habitat restoration, communications and development. There is currently an opening for a policy fellowship, and a habitat restoration fellowship will open soon.

Members thanked Jessica Martini-Lamb and Sara Azat for their service as AC Chair and Vice Chair.

Erik Buehmann shared that the San Francisco Bay Conservation and Development Commission's regional action plan to support beneficial sediment reuse was released recently and is on their website.
